

FLORIDA STATUTE-633 FIRE PREVENTION AND CONTROL

Title XXXVII, Chapter 633, 633.537 Certificate; expiration; renewal; inactive certificate; continuing education.--

(4) The renewal period for the permit class is the same as that of the employing certificateholder. The continuing education requirements for permitholders shall be 8 contact hours by June 30, 2006. An additional 16 contact hours of continuing education is required by June 30, 2008, and during each biennial renewal period thereafter. The continuing education curriculum from July 1, 2005, until July 1, 2008, shall be the preparatory curriculum for NICET II certification; after July 1, 2008, the technical curriculum is at the discretion of the State Fire Marshal. It is the responsibility of the permitholder to maintain NICET II certification as a condition of permit renewal after July 1, 2008.

Title XXXVII, Chapter 633, 633.521 Certificate application and issuance; permit issuance; examination and investigation of applicant.-- (10) Effective July 1, 2008, the State Fire Marshal shall require the National Institute of Certification in Engineering Technologies (NICET), Sub-field of Inspection and Testing of Fire Protection Systems Level II or equivalent training and education as determined by the division as proof that the permitholders are knowledgeable about nationally accepted standards for the inspection of fire protection systems. It is the intent of this act, from July 1, 2005, until July 1, 2008, to accept continuing education of all certificateholders' employees who perform inspection functions which specifically prepares the permitholder to qualify for NICET II certification.
